### Address of ALA President



In his address, ALA President, Atty. Avelino V. Cruz, posed the following questions to the association – "should ALA continue to go the way of other Asian Bar Societies whose work is circumscribed by legal cooperation, research and endless networking? Or should ALA now reach beyond, move vigorously as the ASEAN Charter's exclusive civil society affiliate for law and to help achieve harmonization of laws in real terms?" – to which Atty. Cruz answered that ALA's destiny lies with the latter. Atty. Cruz then mentioned the launch of the ASEAN Economic Community (AEC), whose projects he hopes could move faster through sustained and energetic programs for harmonization of laws. Atty. Cruz urged ALA to commit to fast track effective channels of communications with the ASEAN Summit and its various ministerial agencies to seek approval of its proposals.

Atty. Cruz then referred to the recommendations of the "ALA at the Crossroads" and the "Harmonization of Laws" Working Groups which essentially are: (1) to restructure and reinforce representation in each National Committee to ensure that each Governing Council delegation is more representative of its country's national leadership; and (2) to energize liaison activities with the ASEAN Law Ministers' Meeting (ALAWMM) and the ASEAN Senior Law Officials Meeting (ASLOM) and other crucial agencies of ASEAN so that ALA could help promote ASEAN integration with its unique capacity building resources, legal specializations, and partnered legal institutions. He underscored the immediate step taken by the Philippine National Committee under the leadership of Chief Justice Artemio Panganiban to reinforce national leadership representation, through the formal induction of new Minister-Representatives of the National Committee to the Governing Council.

Atty. Cruz then highlighted a couple of items in the agenda of the 39th Governing Council Meeting – the uploading of the most recent updates of the E-book on ASEAN Legal Systems and the decision of whether to make available online the ALA Law Journal or to leave a hard copy at hand. In closing, Atty. Cruz called on all officials and members of ALA to be mindful always, with a strong sense of urgency, of the need to harness its resources and National Committees for the goals they have set.



## Tributes to Hon. TunArifin Bin Zakaria, Chief Justice of Malaysia, and the Hon. Justice Chao Hick Tin, Vice President of the Court of Appeal of Singapore

On the occasion of the retirement from the service of Hon. Tun Arifin Bin Zakaria, Chief Justice of Malaysia, and of Hon. Justice Chao Hick Tin, Vice President of the Court of Appeal of Singapore, the Hon. Chief Justice Kifrawi Kifli of Brunei and the Hon. Chief Justice Sundaresh Menon of Singapore delivered their respective tributes.



In his tribute to Chief Justice Arifin, Chief Justice Kifli enumerated the various roles Chief Justice Arifin held within the legal profession for 43 years, highlighting therein how he rose through the ranks from Judicial Commissioner of the High Court of Malaya to Chief Justice of Malaysia. Chief Justice Kifli also lauded Chief Justice Arifin's efforts as an advocate of environmental justice, which include the establishment of the Environmental Court, and noted Chief Justice Arifin's membership in the International Advisory Council for Environmental Justice under the United Nations Environment Programme. Chief Justice Kifli mentioned, as well, Chief Justice Arifin's invaluable role in harmonizing laws and civil processes within ASEAN – particularly in amending the Rules of Court of all the ASEAN countries to accommodate the service of process between jurisdictions. Finally, Chief Justice Kifli thanked Chief Justice Arifin for being a model for judicial

conduct in his fairness and wisdom to all those who sit at the Bench.

Thereafter, Chief Justice Kifli proceeded to pay tribute to Justice Chao, a past president of ALA. Considered to be a founding father of the ASEAN Law Association, Justice Chao served ALA for more than three decades. Chief Justice Kifli alluded to Justice Hao as a leading figure in the drafting of the ALA Constitution during his membership of the Working Committee therefor, which was established in February 1979 in Jakarta. Chief Justice Kifli thanked Justice Chao for his leadership during the latter's tenure as ALA President which he described as practical and compassionate. He cited Justice Chao as someone who set the standard for the advancement of ALA, and whose leadership and influence have helped unite the ASEAN legal fraternities and build the foundation for advancing the integration of the various ASEAN legal systems.

In his tribute, Chief Justice Menon said that Chief Justice Arifin, who is blessed with a great legal mind, is held in high regard as a judge of patience and fairness. Chief Justice Menon noted that he has always been struck by Chief Justice Arifin's courteous, open-minded and warm demeanor. He stressed that Chief Justice Arifin has devoted his entire working life to public service in Malaysia and pointed out that, undoubtedly, the combination of his own capabilities, personality and deep experience at all levels of the Judicial and Legal Service have contributed to his inexorable rise to Chief Justiceship in 2011. He said that they worked together to establish and institutionalize the Council of ASEAN Chief Justices, where Chief Justice Arifin attended every meeting, contributed to various projects and led projects on service of civil processes, case management and court technology. He added that as a devoted husband and a proud father and grandfather, he is sure





that Chief Justice Arifin looks forward to his retirement to finally have the opportunity to spend more time with his family. He said that in ALA, Chief Justice Arifin is the personification of the true spirit of golf. He is a perfect gentleman on the course, respectful of the rules yet totally considerate towards his playing partners.

Chief Justice Menon then delivered his tribute to Justice Chao. He spoke of the highest esteem in which Justice Chao is held in ALA as one of the founding members. He emphasized Justice Chao's commitment to ALA such that for almost four decades he never missed a single meeting. He recounted that Justice Chao was elected as President at the 8th General Assembly and it was during his presidency when ALA held its 25th Anniversary Commemorative Session and launched its website and the online edition of ASEAN Legal Systems. This year, Justice Chao will complete 50 years of public service in some of the highest echelons of the Singapore legal establishment. Among Justice Chao's notable achievements are being part of the Singapore delegation which produced the United Nations Convention on the Law of the Sea and being awarded the Distinguished Service Order (Darjah Utama Bakti Cemerlang) by the President of Singapore in recognition of his exemplary service to the nation. Even though Justice Chao will be passing the baton to his younger colleagues, Chief Justice Menon said that he knows that Justice Chao will continue to attend ALA events and to mentor the next generation of ALA leaders.

Other heads of delegations also offered words of commendation to the honorees. The ALA President moved for the adoption of a resolution of recognition and appreciation for the invaluable contributions to ALA of Chief Justice Arifin and of Justice Chao. Upon motion duly made and seconded, the following resolution was unanimously approved by all those present:

"RESOLVED AS IT IS HEREBY RESOLVED that in view of the exemplary and invaluable contributions to, and work of Hon. Tun Arifin Bin Zakaria, Chief Justice of Malaysia, and Hon. Justice Chao Hick Tin, Vice President of the Court of Appeal of Singapore in the ASEAN Law Association, the entire organization extends its utmost gratitude and heartfelt appreciation for everything that they have done for the organization."









### Report of Secretary General



Atty. Regina Padilla Geraldez, A L A Secretary General, reported on matters arising from the minutes and the activities of the ALA President and Secretary General since the last General Assembly. These included the meeting of the Working Group on "ALA At The Crossroads" and the Working Group on the Harmonization of Commercial Laws of the Asean member States held in Makati City on October 7, 2016. Insightful recommendations were generated from the meetings of the Working

Groups. The meetings were followed by a fellowship golf tournament at the Riviera Golf and Country Club at Silang, Cavite. During the Farewell Dinner, the heads of several departments and offices of the Philippine government were inducted as ALA Ministers Representatives to the ALA Governing Council, namely: Executive Secretary Salvador C. Medialdea of the Office of the President, Secretary Vitaliano N. Aguirre II of the Department of Justice, Secretary Arthur P. Tugade of the Department of Transportation, Secretary Rodolfo A. Salalima of the Department of Information & Communications Technology, Solicitor General Jose C. Calida, and Chief Operating Officer and President Alfredo C. Lim of the Philippine Amusement and Gaming Corporation (PAGCOR). The Secretary General also reported that she attended, on behalf of the ALA President, the 49th ASEAN Day Celebration at the ASEAN Secretariat in Jakarta, Indonesia on August 15, 2016. She also participated in the AICHR Judicial Colloquium on the Sharing of Good Practices Regarding International Human Rights Law held in Kuala Lumpur from March 13-15, 2017, together with many other prominent ALA members. Finally, she reported on ALA's compliance with reporting requirements in accordance with the Guidelines of Entities Associated to the ASEAN drawn up by the ASEAN Secretariat.

Justice Chao, together with the other members of the Jakarta Working Committee, drafted the ALA Constitution with a vision for harmonisation of ASEAN laws and close collaboration amongst ASEAN judges and lawyers. Such is Justice Chao's commitment to ALA that he has not missed a single ALA meeting in 38 years since 1979. He is held in high esteem and is well loved by ALA colleagues, and his wise and pragmatic advice has provided clear direction towards achieving the vision of ALA's founding fathers.

Some 500 lawyers, judges and distinguished guests, including the Deputy Prime Minister Teo Chee Hean, the full Supreme Court Bench, and Justice Chao's wife Sen Li, daughters and their spouses, were present as the Hon. the Chief Justice Sundaresh Menon, who is also Chairman of ALA (Singapore), led the chorus of tributes by legal luminaries in Singapore. Chief Justice Menon's address was followed by speeches delivered by the Hon. Minister for Law K Shanmugam, former Minister for Law Professor S. Jayakumar, the Attorney-General Lucien Wong, the President of the Law Society Gregory Vijayendran, the Registrar of the Supreme Court Vincent Hoong and the Hon. Judge of Appeal Andrew Phang (who succeeds Justice Chao as Vice-President of the Court of Appeal). A book entitled "A Judge for the Ages – Essays in Honour of Justice Chao Hick Tin", which includes a compilation of essays on his remarkable contributions to diverse areas of Singapore jurisprudence, was also launched in conjunction with this event.

On Justice Chao's retirement, Chief Justice Menon said, "I congratulate Justice Chao in having completed a most remarkable five decades of distinguished public service in the law. Justice Chao is held in the highest esteem by all segments of the legal profession in Singapore and also throughout ASEAN. He is not only well respected for his legal mind and excellent judicial temperament, but he is also greatly admired and loved for his humility, kindness and wisdom. He will be greatly missed on the Bench."

We are glad to report that Justice Chao has not retired from ALA, and intends to continue his involvement in ALA for many more years to come!

### **NEWS FROM ALA THAILAND**

The Honorable Chief Justice Cheep Jullamon is appointed as the new President of the Supreme Court of Thailand.



Chief Justice Cheep Jullamon has received the royal endorsement appointing him as the President of the Supreme Court of Thailand since October 1, 2017.

Chief Justice Jullamon was born on February 16, 1954. He graduated with a Bachelor of Laws degree with second class honours from Ramkanhaeng University. He also earned Master of Public Administration from Chulalongkorn University and Honorary Doctor of Law from Ramkanhaeng University.

Chief Justice Jullamon entered the Judiciary of Thailand as Judge-Trainee in 1980. Thereafter, He served as Chief Judge of the Chiang Mai Provincial Court, Presiding Judge of the Civil Court, Research Justice of the Supreme Court. During his distinguished career on the Thai bench, he served as Chief Justice of the Criminal Court, President of the Court of Appeal, Regions I and III and the Vice – President of the Supreme Court.

Presently, Chief Justice Jullamon also serves as Chairman of National Committee of ASEAN Law Association of Thailand, Chairman of the Judicial Commission, Chairman of the Judicial Administration Commission, Chairman of the Commission on Jurisdiction of Courts and President of the Thai Bar.

One Step Closer: Promoting ASEAN integration through the Harmonization of Commercial Laws



The ASEAN Law Association National Committee of Thailand successfully organized an academic conference entitled "One Step Closer: Promoting ASEAN Integration through the Harmonization of Commercial Law" during 4 - 5 September 2017 at Arnoma Grand Hotel, Bangkok. The event was co-hosted by the International Institute for Trade and Development (ITD), the Thailand Arbitratoin Centre (THAC), the Ministry of Foreign Affairs of Thailand and the UNCITRAL Regional Centre for Asia and the Pacific, and was well-attended by government officials, legal practitioners and academics, both from Thailand and abroad.

The Conference served to raise awareness for the need to harmonize the commercial laws of ASEAN Member States, bringing together public and private entities involved in cross-border trade, legal practitioners, policymakers, academics and other stakeholders to share their insights and experience.
